Dear Ms Israel,

I have pleasure in inviting you to advise the International Atomic Energy Agency (IAEA) during the **Consultancy Meeting to Finalize the IAEA Publication on "SPECT/CT in Clinical Use"** to be held at the IAEA's Headquarters in Vienna, Austria from **14 to 18 January 2019**.

The purpose of the event is to finalize the IAEA publication on "SPECT/CT in Clinical use", prepared during the consultancy meeting on "Clinical Application of SPECT/CT held in Vienna, from 5 to 8 February 2018.

The event will commence at 9:30 a.m. on Monday, 14 January 2019, in room A2278, A Building of the Vienna International Centre (VIC). You are requested to arrive at Checkpoint 1/Gate 1 of the VIC one hour before the start of the event on the first day, in order to allow sufficient time for your grounds pass to be issued, as such passes are necessary for official visitors to the VIC.

The IAEA will provide you with a lump sum equivalent to €1879 for the travel expenses to and from Vienna, Austria and for living expenses, including incidentals, connected with the event. You will be fully responsible for making your own travel arrangements and for cancellation costs, if any. This amount has been calculated on the assumption that you will stay for the total duration of the event. Should this not be the case, you would be requested to reimburse the IAEA for the appropriate difference.

It is understood that your travel and living expenses are not covered fully from any other source.


This arrangement does not constitute, and shall not be construed to create, an employment relation between the IAEA and yourself. Accordingly, the IAEA will not pay employer's contribution to any social security scheme or health insurance scheme in connection with services performed by you under this arrangement.

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in IAEA events or for consultants. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.
